QUALITY APPRAISAL OF PRODUCTS AND DESIGN

- The participant in the quality assessment of products shall accept prices from the Application Form - Quality Assessment Agreement. Prices are stated without VAT.
- Exhibitors at the 92nd International Agricultural Fair shall be entitled to **the discount of 20%** on specified prices.
- The deadline for the application is 24th March 2025.** Completed Application Form shall be sent by e-mail, and the original Application Form shall be sent by mail. **Samples shall be delivered** not later than on **24th March 2025** to the address of the Novi Sad Fair in quantities according to the agreement.
- On the basis of the signed Application Form, the Fair shall send to the participant in the quality assessment a PRO FORMA INVOICE for everything that has been specified in the Application Form.
- By signing this Application Form - Agreement, the participant in the quality assessment shall agree to the method of payment specified in the Application Form and guarantee the accuracy of information given in the Application Form.
- It is compulsory for the fee for the quality assessment to be paid before the beginning of the work of the Product Quality Assessment Commission**, that is, on 24th March 2025 in accordance with delivered pro forma invoice. The subject matter of assessment shall be only those samples of participants for which the fee has been paid before the beginning of the work of the Commission.
- Every legal entity or natural person - signatory of this Application Form – Agreement shall be obliged to pay for contracted services in accordance with the pro forma invoice before the beginning of the work of the Quality Assessment Commission. **The payment can be made only by the person (legal entity or natural person) with whom the Agreement–Application Form has been concluded as a service beneficiary by a payment order of a commercial bank.**
- The Quality Assessment Commission shall work in compliance with the "Basic Rulebook on the Quality Assessment of Products and Services", the "Rulebook on the Quality Assessment of Detergents and Other Cleaning Products Based on Surfactants", the "Rulebook on the Quality Assessment of Motor and Hydraulic Oils", the "Rulebook on the Quality Assessment of Microbiological Fertilizers and Preparations", the "Rulebook on the Quality Assessment of Mineral Fertilizers", the "Rulebook on the Quality Assessment of Pesticide Preparation Products" and the "Rulebook on the Quality Assessment of Other Chemical Products" of the Novi Sad Fair. The evaluation committee for the "Good Design" award will work according to the "Rules for the Evaluation of Good Design" of the Novi Sad Fair. Top quality samples can be nominated by the Commission for the recognition "Champion of Quality in the Product Group".
- Winning the recognition in the quality assessment shall entitle the participant in the quality assessment to use the Fair's Trademark in media promotion of products and in their own promotion at the market in compliance with applicable regulations.
- The results of the quality assessment shall be published at the website of the Novi Sad Fair, www.sajam.net, where there are also Rulebooks and Application Forms for the quality assessment.
- After the completion of the provision of contracted services, the participant in the quality assessment shall be provided with the final invoice with the specification of all actually used services and the calculation of tax liabilities in compliance with applicable legal regulations. The VAT shall be borne by the buyer. The signatory of this Application Form shall be obliged to pay the debt in full within the deadline specified in the final invoice.
- In case of any disputes, the contracting parties shall agree on the court of competent jurisdiction in Novi Sad.
